

**RD Wallet 731 Onsite Event Campaign
Terms and Conditions (“Promotional T&Cs”)**

**圓幣錢包 731 現場推廣活動
條款及細則（「推廣條款及細則」）**

1. This RD Wallet 731 Onsite Event Campaign (“**Campaign**”) is hosted by RD Wallet Technologies Limited (“**RD Technologies**”) and is exclusive to participants who have attended the 731 Onsite Event held at RD Technologies’ office on 31 July 2024 on behalf of a business entity (“**Business**”), with the promotional period commencing from 31 July 2024 until 31 August 2024, both dates inclusive (“**Promotional Period**”).

本圓幣錢包 731 現場推廣活動（「**推廣活動**」）由圓幣錢包科技有限公司（「**圓幣科技**」）舉辦，並僅限代表企業實體（「**企業**」）出席 2024 年 7 月 31 日在圓幣科技辦公室舉行的 731 現場推廣活動的參與者參加，推廣期由 2024 年 7 月 31 日至 2024 年 8 月 31 日止，包括首尾兩日（「**推廣期**」）。

2. A business entity (“**Business**”) is entitled to enjoy the account opening fee rebate - under this Campaign (“**Account Opening Fee Rebate**”) provided that it satisfies all of the eligibility requirements (“**Eligibility Requirements**”) pursuant to paragraph 3 of these Promotional T&Cs:

3. **Eligibility Requirements**

合資格要求

- (a) In order to qualify as an eligible customer to enjoy the Account Opening Fee Rebate (“**Eligible Customer**”), the Eligibility Requirements must be satisfied by the relevant Business:

相關企業必須滿足以下合資格要求以成為合資格客戶享有開戶回贈獎賞（「**合資格客戶**」）：

- (i) apply for an RD Wallet account for the Business via the RD mobile application (“**RD App**”) using the referral/exclusive code “**RDET20**” during the Promotional Period; and

在推廣期內透過 RD 流動應用程式（「**RD 應用程式**」）使用優惠碼（專屬碼）「**RDET20**」為企業申請開立圓幣錢包賬戶；及

- (ii) successfully open an RD Wallet account for the Business, with the prevailing account opening fee having fully settled by the Business on or before 31 October 2024.

於 2024 年 10 月 31 日或之前成功為企業開立圓幣錢包賬戶並已將現行開戶費用全數結清。

- (b) Please refer to the latest Fee Schedule of RD Wallet published on RD Technologies’ website for further details on the account opening fee.

- (c) Any account opening fee payment transaction made by the eligible customers through RD Technologies' authorised channel(s) will be subject to their respective terms and conditions (including payment of any additional fees and charges) and RD Technologies shall not be liable for breach of such terms and conditions by any party.

合資格客戶透過圓幣科技認授的渠道進行的任何開戶費用付款交易均須受到其訂立的條款及細則約束（包括繳付任何額外費用），且圓幣科技並不對任何一方違反該等條款及細則承擔責任。

- (d) For the avoidance of doubt, the application for opening an RD Wallet account will be subject to RD Technologies' internal verification and approval process. RD Technologies shall, under its sole and absolute discretion, exercise the right to decline any customer to open an RD Wallet account due to the applicable regulatory and licensing requirements and/or any other reasons.

為避免疑義，開立圓幣錢包賬戶的申請需要通過圓幣科技內部驗證及審批程序。圓幣科技可基於適用的監管及牌照要求及/或其他原因行使其唯一和絕對的酌情權拒絕任何客戶開立圓幣錢包賬戶。

4. Account Opening Fee Rebate

開戶回贈獎賞

- (a) Eligible Customer is entitled to receive the Account Opening Fee Rebate equivalent to 20% of the prevailing account opening fee, depending on their business type and place of incorporation/registration as set out below:

- (b) The Account Opening Fee Rebate will be made available to each Eligible Customer in the form of a gift coupon at the gift centre of its respective RD Wallet Account on a one-off basis, provided that the status of such account remains active and valid as at the date of issuance of the gift coupon. Such gift coupon is non-exchangeable for cash and other rewards and is non-transferrable.

獎賞將以優惠券的形式在其各自的圓幣錢包賬戶內的禮品中心作一次性發放，但前提是該賬戶在優惠券發放日必須保持為活躍及有效狀態。該優惠券不可兌換成現金及其他獎賞，亦不可轉讓。

5. RD Technologies will determine the Eligible Customer's entitlement to the Account Opening Fee Rebate based on its system records. In case of any dispute, the amount of Account Opening Fee Rebate which each Eligible Customer is entitled to receive as recorded by the system of RD Technologies shall be final and conclusive. No prior notice will be given to the Eligible Customers for any early termination of the Campaign.

圓幣科技將根據其系統記錄以確定合資格客戶獲取開戶回贈獎賞的權利。如有任何爭議，圓幣科技系統所記錄的每位合資格客戶可獲取的開戶回贈獎賞應被視為最終並具決定性的。本推廣活動如提前終止，恕不另行通知。

6. Upon satisfaction of the Eligible Requirements, the Account Opening Fee Rebate will be awarded to the Eligible Customers pursuant to paragraph 4 (b) of these Promotional T&Cs no later than 45 business days after 31 October 2024.

在滿足合資格要求後，開戶回贈獎賞將根據本推廣條款及細則第 4(b) 段在不晚於 2024 年 10 月 31 日起 45 工作天後之日期發放於合資格客戶的圓幣錢包賬戶。

7. RD Technologies reserves the right to change the fulfilment date of the Account Opening Fee Rebate at its sole and absolute discretion. In the event of any such change, RD Technologies will notify the Eligible Customers as soon as possible, however a prior notice is not guaranteed.

圓幣科技保留權利根據其唯一和絕對的酌情權更改開戶回贈獎賞發放日。如開戶回贈獎賞發放日有任何變更，圓幣科技將盡快通知合資格客戶，但並不保證能作出提前通知。

8. Directors and employees of RD Technologies and the Eligible Customers who remove the Business Profile and/or cease to maintain an active RD Wallet account on the RD App at the time of fulfilment of the Account Opening Fee Rebate will not be entitled to receive the Account Opening Fee Rebate.

圓幣科技的董事及員工、以及合資格客戶如在發放開戶回贈獎賞時已在 RD 應用程式上刪除企業檔案或停止保持圓幣錢包賬戶的活躍狀態，將不可享有開戶回贈獎賞。

9. If any Eligible Customer is believed to have acted in a fraudulent or abusive way to obtain the Account Opening Fee Rebate, RD Technologies reserves the right to deduct or revoke the Eligible Customer's entitlement of Account Opening Fee Rebate and terminate the Eligible Customer's accounts on the RD App (including the removal of the respective Business Profile and RD Wallet account) without further notice.

如任何合資格客戶被認定以欺詐或濫用的方式獲取開戶回贈獎賞，圓幣科技保留扣除或撤銷合資格客戶獲取開戶回贈獎賞的權利及終止合資格客戶在 RD 應用程式上的任何賬戶（包括刪除已建立的企業檔案或圓幣錢包賬戶）的權利，恕不另行通知。

- RD Technologies reserves the right to suspend, vary or terminate the Campaign at any time and amend these Promotional T&Cs from time to time under its sole and absolute discretion without prior notice. The latest details relating to the Campaign and any revised Promotional T&Cs will be made available on RD Technologies' website and/or communicated to the Eligible Customers by other means as soon as practicable. In case of any dispute, the decision of RD Technologies on all matters relating to the Campaign shall be final and binding on all parties concerned. RD Technologies shall not be liable for any claim, loss and/or liability arising out of or suffered from the variation or termination of the Campaign and/or these Promotional T&Cs.
